This shall include, subject to the terms and conditions listed below, the right to use the provided images of OLIGO Lichttechnik GmbH for advertising and sales purposes, including on your website or use in your online shop.



In case any provision of this contract is wholly or partially invalid or unenforceable, or loses its effectiveness later on, the validity of the remaining provisions of this agreement shall not be affected. In this case, the Parties shall replace the invalid or unenforceable provision by a valid or enforceable one which comes closest to the intended purpose of the contract. This also applies to any gaps in the contract.
